# **PAYMENT POLICY**

This policy defines the payment methods accepted by TUNISAIR and which the Agents shall comply with in all areas. The Agent must respect all applicable payment laws and regulations of each country.

## Methods of payment

For tickets issued through BSP/ARC, TUNISAIR accepts the following payment methods from travel agents

- Cash
- UATP
- IATA EasyPay
- Credit Card

#### Cash

TUNISAIR accepts cash as a payment method subject to the amount limits set by the regulations of each country.

#### **UATP**

TUNISAIR accepts payment by UATP card (See attached list which will be updated upon each change of information). Should an airline be in default of payment, TUNISAIR will proceed to the recovery of the uncollected amounts in accordance with its ADM policy.

### **Credit cards**

The Agent is required to comply with the rules and procedures described in IATA Resolution 890 (Card Sales Rules).

The Agent will ensure that the type of Customer Card merchant agreement, being processed during the sale is accepted for payment

by TUNISAIR, both for each country and each GDS (See attached list which will be updated at each change of information).

### IATA EasyPay

TUNISAIR accepts EasyPay as a payment method in those markets where the NewGen ISS program is implemented.

## **Payment policy violations**

If the Agent violates this payment policy, this will result in the issuance of ADMs to recover all associated costs incurred by TUNISAIR on these transactions, in addition to the audit process costs as stipulated in TUNISAIR's ADM policy.
